Refund Policy:

- The student may cancel this contract at any time prior to midnight of the third (3rd) business day after signing this contract.
- The student will receive a full refund of tuition and fees if the school discontinues a course / program within a period of time a student could have reasonably completed it, except that this provision shall not apply in the event the School ceases operation.
- If the student has cause of urgent concern that delays the starting date if the course (death in the family, serious illness, etc.) the tuition will be held until the time of the student's availability to attend the next available class.
